#### T.H.R.I.V.E.

empowers women by providing education about Family Violence and opportunities to learn new strategies and life skills to support new life changes.

#### T.H.R.I.V.E.:

- Helps women understand that although everyone's experience is different, they are not alone.
- Provides a safe, confidential place to talk about your thoughts, feelings, experiences and get information and/or support.
- Offers a women a chance to discuss questions, confusion or fears about their relationships.
- Women are able to identify their strengths and goals, make sense of options, and be better able to make decisions.
- Women are offered healthy ways for coping with overwhelming emotions.

#### Why Learn About Family Violence?

- No one ever deserves to be abused and no one has a "right" to be abusive.
- Family Violence is the use of intimidation and fear to maintain power and control over a family member. It can include physical abuse and it can also include any form of disrespectful behavior against those claimed to be loved.
- Family Violence is learned behavior.
   It is behavior that CAN be changed.
- Family Violence destroys the human spirit.
