DRUG TESTING SERVICES PROGRAM

The Probation Services Division administers drug testing for clients in accordance with their conditions of release or probationary term.

If you are ordered to submit to drug testing you will be given specific instructions by your assigned probation officer/case manager. You must follow these instructions.

Ordinarily clients are instructed to **call on specific days of the week before 9am** to inquire if they will be tested.

If you are instructed to report for testing you have exactly **one (1) hour** travel time to report to the Office Duty Section of the Probation Services Division. Once you check-in for testing you have **two (2) hours to submit a valid urine sample** for analysis. All drug tests are witnessed by a tester and an observer. A valid urine sample has a temperature between 90°-100°; is yellow in color, and is an adequate amount to be tested and to undergo confirmation testing, if necessary (60ml).

You must keep in mind that other clients in similar situations are tested on a first come,

first served basis; thus there will be a waiting period. Remember that you cannot leave the testing site and you are not allowed to consume any food or beverage while you wait. You are allowed an eight ounce glass of water monitored by Probation staff every hour. Probation also administers alcohol breath tests and saliva testing.

In accordance with the Division of Probation Services Client Substance Abuse Testing Contract the following will be considered violations of the drug testing program:

- Your failure to call or appear for testing.
- Late arrival for testing.
- Stall: appearance for testing, yet failure to submit a valid urine sample within 2 hours; insufficient sample for testing; or failure to submit a breathe sample.
- Positive results for controlled substances.
- Any use of alcohol for clients with a "NO ALCOHOL" condition.
- Tampering with urine specimen or breath sample



- Adulterated urine specimen or diluted sample.
- Attempted substitution or tampering with urine specimen.
- Consuming anything by mouth during the testing process without permission of the tester.
- Any attempt to obstruct the test procedure or leaving the test site.

Any of the above violations shall result in notification to the court. You may challenge the results of a drug test but you must pay for off-island confirmation testing expenses (approximately \$80.00 or more).
